MEMORANDUM OF UNDERSTANDING

- Purpose.** This Memorandum of Understanding (MOU) is used to form a collaborative partnership between Heritage Education Land Prosperity, Inc. (H.E.L.P. Center) and _____ (Agency Partner), located at _____, Email: _____, Phone: _____, to work in conjunction to provide housing and supportive services to all those who are experiencing homelessness, including transition services to those currently in shelters. This MOU represents a non-binding expression of intent between both parties to also work together to participate in community discussions, webinars, and panels as appropriate.
- Problem.** Both the H.E.L.P. Center and its Agency Partner agree that homelessness knows no race, ethnicity, age, gender, sexual orientation, or region. It is an international and national issue, and there are over 650,000 people who sleep on the streets in the U.S. every single night.
- Scope.** This MOU will cover all those working, volunteering, and participating in programs, projects, and fundraisers in connection with the H.E.L.P. Center and its Agency Partner, including tribes and tribal nations with which the H.E.L.P. Center has a close association.
- Understandings, agreements, support and resource needs.** Both parties agree to work collectively and collaboratively, and communicate whenever possible, to provide assistance to clients needing housing and/or supportive services. The H.E.L.P. Center shall provide to Agency Partner a regular and reasonable follow-up regarding services provided to clients that Agency Partner refers to the H.E.L.P. Center. It is expected that Agency Partner will also provide follow-up referral. Both parties agree to ensure confidentiality of client information when requested.
- MOU period.** This agreement shall remain in force until either party presents a written request to discontinue the collaborative partnership.
- Disbursements.** N/A. Donations can occur but are not required.
- Effective date.** This MOU will go into effect and is effective on the dates accompanying the parties' signatures below.
